<b>AFTER APPLICATION</b>	
<b>Acceptance and Visa Procedures</b>	<p><b>After being accepted by CAU, students are responsible for obtaining their visas.</b> Students must prepare required documents beforehand individually and visit the Korean Embassy/Consulate/Visa Centre in their home countries to apply for a valid student visa.</p> <p>* Students from the following 26 countries may be requested additional financial documents: Bangladesh, Cameroon, China, Egypt, Ethiopia, Ghana, Guinea, Kazakhstan, Kyrgyzstan, India, Indonesia, Iran, Mali, Mongolia, Myanmar, Nepal, Nigeria, Pakistan, Peru, Philippines, Sri Lanka, Thailand, Ukraine, Uganda, Uzbekistan, Vietnam</p>

<b>About Student Visa (D-2-6)</b>	<p><b>1. Student must enter Korea with a <u>valid D-2-6 Student Visa</u>. (Not a Tourist Visa)</b> Students must obtain their Student Visa (D-2-6) at least a week before the semester begins. Without a proper Student Visa (D-2-6), students cannot study at CAU. * Students who enter Korea with a Tourist Visa <b>cannot change</b> it into a Student Visa (D-2-6) in Korea.</p> <p><b>2. Please do not use your Student Visa (D-2-6) to travel to Korea before the semester starts and go back to your home country (or to a third country), since the <b>Student Visa (D-2-6) is for single-entry</b>.</b> If you want to come earlier and travel with your Student Visa (D-2-6), <b>you cannot leave Korea until you create your RC (Registration Card)</b>. If you do leave, the student visa will automatically be terminated and you will no longer be able to study at CAU as an exchange student.</p> <p><b>3. After arrival, students must create an RC (Registration Card).</b> The RC is mandatory for all exchange students, and it acts as a legal permit, which allows students to live in Korea for their entire study period, as well as exit and enter the country freely. Students wishing to leave the country after arrival must book their RC appointment at the Immigration Office <b>in advance of leaving the country</b> so that they can gain re-entry permission. CAU offers group RC application service, so students do not have to make individual appointments. It takes about 7-10 weeks to receive the RC.</p> <p><b>4. <b>Students should leave Korea within 30 days of the semester-end date, regardless of the expiration date of RC.</b></b> * Although the RC may be valid after the semester ends, the OIA will terminate the student's visa on the last day of semester. Therefore, those who are not staying for another exchange semester <b>SHOULD</b> depart within 30 days after semester ends.</p>					
<b>Orientation and Arrival Date</b>	<p>CAU provides on-campus orientation held the week before semester starts. Students are recommended to arrive at least a day before the orientation.</p> <p>Students living on campus should arrive between the dormitory check in period. It is usually 2 to 3 days before the semester begins. The dormitory check in period will be announced later to accepted students via email. Any student arriving earlier than the official move-in date of the dormitory should find their own accommodation until they can move-in.</p>					
<b>On-Campus Housing</b>	<table><tr><td rowspan="2"><b>Application Period</b></td><td><b>Spring</b></td><td>December of previous year</td></tr><tr><td><b>Fall</b></td><td>June</td></tr></table> <p>* The dates are subject to change.</p> <p>Students who wish to live in on-campus dormitory needs to apply through the online application page from a link provided by the OIA, which will be sent when the dormitory dates are fixed.</p> <p><b>It is on a <b>first-come, first-served</b> basis. Please make sure to not miss the deadline as the dormitory availability is very limited and competitive.</b></p> <p>If a student wants to cancel the application for the dormitory, they need to <b>give notice at least three weeks before the beginning of the semester</b> by emailing <a href="mailto:inbound@cau.ac.kr">inbound@cau.ac.kr</a>.</p> <p>If a student cancels their dormitory application after this period, they may still need to pay the dormitory fee, depending on the dormitory's refund policy.</p> <p><b>A Tuberculosis (TB) Test result <u>in English or Korean</u>, taken <u>within 4 weeks</u> before the dormitory move-in date is also required.</b> The test should include student's name, hospital/clinic name,</p>	<b>Application Period</b>	<b>Spring</b>	December of previous year	<b>Fall</b>	June

	date of the test, and test results <u>in English/Korean</u> . The test can be conducted in Korea, and in the form of a skin test, blood test, or X-ray. Please bring the original test result to the dormitory move-in.
<b>Tuition and Dormitory Payment</b>	<p>Fee-paying students must pay the tuition in full to CAU by the given tuition payment period. The dormitory fee must be paid in full during the announced dorm payment period for exchange students. Once the exact period is released, students will be informed by email. Students are recommended to withdraw cash and bring the required amount in advance when entering Korea. <b>Late payments are unacceptable.</b> <u>As the dorm office will not accept overseas payment, students are recommended to withdraw enough cash for the dorm fee and bring them when entering Korea</u> to make domestic transaction.</p>
<b>Course Registration Restrictions</b>	<p>Students may take courses from different departments and colleges with certain restrictions. The following are the restrictions students should be aware of regarding course enrollment:</p> <ol style="list-style-type: none"> <li>1. During the 1<sup>st</sup> course registration period, all other majors <b>CANNOT</b> enroll in <b>business courses and art courses</b>. Business majors can enroll in any <u>courses from all majors</u>, except art courses. This is due to the high competition in the business department.</li> <li>2. <b>Only</b> art majors can enroll in art courses during all three course registration periods.</li> <li>3. Exchange students who would like to take courses in the School of Architecture and Building Science (College of Engineering):             <ol style="list-style-type: none"> <li>1) Should be majoring in a similar major in their home universities</li> <li>2) Should have taken the prerequisite courses if required by CAU</li> <li>3) The home university must be accredited for Architecture / Architectural Engineering.</li> </ol> </li> </ol> <p>* If students enrol in incorrect courses, it will be notified by email before the semester starts.          * <u>The course registration detail may be canceled regardless of student's situation depending on the course restrictions.</u></p>
<b>National Health Insurance Service</b>	<p>ALL international students are subject to a mandatory subscription to the National Health Insurance Service (NHIS), operated by the Korean government. The subscription is automatic. The NHIS will be active once the registration number is issued, and a bill will be sent to each student's Korean address, which is one put when applying for RC.</p> <p>* Amount: approx. 70 USD per month</p> <p>Students with NHIS will have the same benefits as Korean nationals, including dental and oriental medical treatment, health checkups, etc. There will be restrictions on health insurance benefits, visa extensions, etc, if the fee is unpaid. Students may also be restricted in their study period extension at CAU.</p> <p>* Contact: <a href="#">NHIS website</a>, NHIS Customer Service (1577-1000, dial 7 for information in other languages), NHIS Foreign Language Consultation (033-811-2000)</p> <p>* Private insurance from home country <b>does not</b> exempt NHIS requirements.</p> <p>All exchange/visiting students are responsible for National Health Insurance Service payment for themselves. The OIA will not financially support any student in case of accidents or injuries.</p>

<b>Intensive Korean Courses (Fee-paying program)</b>	<p><b>Seoul Campus:</b> 16 Korean courses of 3 different levels available</p> <p><b>Da Vinci Campus:</b> 2 Korean courses of 1 level available</p> <p>Both campuses provide an ideal setting for those who want to study Korean language and culture together with other academic courses. Courses are divided into 2 time slots (9:00-13:00 and 13:00-17:00). The time slot will be decided according to the level of the student. International exchange students can take these courses for a 25% discounted fee. Since it is not a regular course, it does not bear academic credits.</p> <p>* Students should contact <a href="#">CAU's Institute of Language Education</a> for details.</p>
